In 2016, Texas Health and UT Southwestern Medical Center created Southwestern Health Resources, an integrated network that blends the strengths of the two organizations to better serve North Texas residents, from preventive care to the most advanced interventions. Texas Health and Aetna also in 2016 announced the creation of a jointly owned health plan company that will focus on improving quality, affordability and the overall consumer and provider experience.

Berdan became CEO of Texas Health on Sept. 1, 2014, after serving as senior executive vice president and chief operating officer the previous two years. He joined Texas Health in 1986 as vice president/administrator for Texas Health Southwest. He then served at Texas Health Fort Worth from 1993 to 2007, initially as chief operating officer and finally as president. He was Texas Health's senior executive vice president for system alignment and performance from 2007 to 2012.

Berdan earned a Bachelor of Science degree in biology from Texas Christian University in Fort Worth and a master's degree in business administration with a specialization in hospital administration from the University of Chicago Graduate School of Business.

Active in his community, Berdan has served as chairman of the Texas Hospital Association and received the association's highest honor, the Earl M.
